Legal requirements and attraction information

Public Liability	LEGOLAND Discovery centres are covered by Public Liability Insurance to the amount of £10 million. The Policy is with Chubb European Group Limited (Policy No UKCANC33447).
Local Enforcement Agency	LEGOLAND Discovery Centres are enforced by Birmingham City Council. Please email ldc.birmingham@merlinentertainments.biz if you require further information.
Rides Engineering / Maintenance	There are 2 mechanical rides on site. Rides are safety checked every morning and continuously manned by a trained member of staff when in operation.



Food Safety and Hygiene	The food unit operates in accordance with the Food Safety Act 1990 and are regularly inspected by the local Environmental Health Department and undergo regular internal health and safety audits carried out by Merlin Entertainments.
Attraction Staff / Staff identification	All attraction staff wear uniforms and name badges for easy identification.
Security	Arena Birmingham which LEGOLAND Discovery Centre is part of has a dedicated security team who are able to deal with minor security issues on site. The team is also trained to deal with emergency incidents that may arise.
COVID-19	We've been awarded the VisitEngland 'We're Good to Go' industry charter mark. This verifies that our attraction meets the Government and public health guidance on COVID-19 and that we have all the required health and safety processes in place to ensure you have a safe and enjoyable visit.
Risk assessment	
Vehicle traffic	N/A.
Weather protection / Sun safety	The attraction is indoors so weather protection is not required.
Water	The attraction is indoors so water should not be an issue.
Slips/ Trips/ Falls	The following hazards should be noted: <ul style="list-style-type: none"> • Trips caused by looking in the attraction and not at the floor • Wet flooring • Steps and stairs
High level areas	Supervision is required and there is no climbing on the barriers.
Strobe lighting	Strobe lighting effects are used in certain areas throughout the attraction.
Reduced lighting	Care should be taken due to reduced lighting in certain areas.
Enclosed spaces	Some parts of the attractions could make individuals feel confined due to being dark, warm and humid. However there are no areas in the attraction that can be defined as a confined space.
Attraction specific risk	The attraction contains lots of LEGO pieces and these can add an additional hazard to the environment.
Door entrapment	Beware of closing doors on fingers etc
Rides	Certain restrictions on rides including height and needing accompanying adult supervision to minimise risk. Rides operated by trained staff members at all times. Safety bars are used to secure riders.



Soft play areas / Play equipment	LEGO Bricks are a choking hazard to under 3s. DUPLO bricks available. There are 3 soft play areas, including 2 for Under 5s only. Lager child soft play area is undercover and may cause supervision difficulty. Hazard in soft play includes slips, trips and falls. Adult supervision required with LEGO, soft play and play equipment at all times.
COVID-19	<p>All guests are asked to remain with their family/friends/group and to keep a safe distance from other guests. To reduce proximity between our team and guests we have changed how we undertake our guest services, including the installation of hygiene screens at our service counters.</p> <p>Our team participate in COVID-19 specific training programmes instructing them how to stay safe as well as how to keep our guests safe. We have also introduced personal protective equipment (PPE) requirements for our team. Some experiences may be unavailable or have restrictions on the number of guests to help ensure there is plenty of room.</p> <p>You will find hand sanitiser stations around the attraction for guests to use. Enhanced cleaning will take place throughout the day and we will undertake deep cleaning measures in the event that a person presents themselves with symptoms consistent with COVID-19.</p> <p>In support of the NHS Test and Trace program, your contact details may be shared with NHS Test and Trace, if asked, in the event of a fellow guest testing positive for coronavirus.</p>
Attraction arrangements	
Arrival arrangements	If you are bringing a group by minibus or coach and need to drop off and pick up your group, you can do this on Kind Edwards Road. There is no localised coach parking.
Parking	Please go to the 'Visitor Information' pages on the website for the most convenient car park in relation to the attraction.
First aid	LEGOLAND Discovery Centre has it's own first aiders on site. access to this facility when required. Nearest hospital: City Hospital
Emergency planning	LEGOLAND Discovery Centre has a contingency plan in the event of an emergency. The emergency plan has been developed in conjunction with the local emergency services who have regular meetings regarding emergency procedures.
Fire safety	In the event of an emergency please follow all evacuation procedures.
Wheelchair access	LEGOLAND Discovery Centre is fully accessible. There is a lift to access the first floor and a changing space within the attraction.
Lost children	Please report to member of staff.



Unruly children	The attraction has regulations displayed at the entrance. Staff are trained to enforce these regulations for the benefit of all guests. Staff will instruct children to behave where necessary. Children should be supervised by an adult at all times.
Age / height restrictions	All children must be accompanied by an adult and supervised at all times. An adult is classed as aged 18 and over. Children are classed as aged 17 and under. Adults must be accompanied by a child to enter the centre.
Lockers / storage facilities	There are no lockers or storage facilities.
Eating facilities	LEGOLAND Discovery Centre does have a Schools Lunch Room onsite, however this is subject to availability and must be booked in advance. If you are unable to secure a time slot for the lunch room we do recommend lunch in Brindley Place outside the attraction if we can not accommodate you. Please note, we are able to store lunches or bags for your group.
Welfare facilities	There are toilets located within the attraction – they are situated within the hub area.
Additional costs	There is a retail outlet and picture booth where additional funds may be appropriate.
Attraction signposting	LEGOLAND Discovery Centre is a free flow attraction. We would therefore recommend splitting and exploring in smaller groups with assigned meeting points or areas at certain times.
COVID-19	<p>Before you visit:</p> <p>We will be updating our social media pages and website with the latest information, keep checking back for updates and before leaving home, please check our website and social media pages for the latest information. Should you or any member of your group start displaying any of the symptoms associated with COVID-19 please refrain from visiting. Please contact customer services should you need to amend your booking.</p> <p>When you arrive:</p> <p>All adults/teachers and any students over the age of 11 will be required to wear a face covering when visiting the attraction.</p> <p>You and your group will be temperature checked prior to entry. If anyone in the group is displaying a high temperature associated with fever (above 37.8 degrees Celsius), the whole group will not be permitted to enter the attraction.</p> <p>Please always remain within your group, keeping a safe distance between you and other guests. You will notice information signage informing guests of key safety messages and instructions. Please ensure you consider your teacher to child ratio to help enforce/manage this.</p>
